#### ARTICLES OF INCORPORATION

The undersigned Company, for the purpose of forming a nonprofit corporation, pursuant to the provisions of the "Alabama Nonprofit Corporation Act" does hereby certify as follows:

ARTICLE I NAME

The name of the corporation is DIXIE ABATE, INC.

### ARTICLE II DURATION

The Corporation shall have a perpetual duration from the date of organization, unless it is dissolved and its affairs wound up prior to that date in accordance with the Alabama Nonprofit Corporation Act (the "Act").

## ARTICLE III PURPOSE

The purposes for which the Corporation is formed are:

Dixie ABATE, Inc., is organized for charitable, educational, civic, benevolent, social, and athletic purposes including for such purposes, the promotion of motorcycle use, acceptance, safety, and enjoyment. Said purposes include promoting the motorcycling interests of the corporation's members and affiliates. Said corporation is further organized to undertake such interaction, including lobbying, and litigation support with various governmental bodies as may be necessary or desirable to promote the motorcycling interests of the corporation's members and affiliates.

To do any and all of the things herein set out and such other things as are incidental or conducive to the attainment of the objects and purposes of this Corporation, to the same extent as natural persons might or could do and in any part of the world, as principal, factor, agent, contractor, or otherwise, either alone or in conjunction with any person, firm, association, partnership, corporation or any entity of whatsoever kind, and to do any and all such acts and things and to have and exercise any and all such powers to the full extent authorized or permitted to a corporation under any laws that may now or hereafter be applicable or available to this Corporation.
